

Maybank VISA Golf Program 2026

Terms and Conditions

1. This opportunity to participate in the Maybank VISA Golf Program 2026 ("Event") from 4 July 2026 to 7 July 2026 ("Event Date") is applicable to Cardmembers in Malaysia, Indonesia, Singapore, Cambodia, Philippines and/or Brunei. Under this opportunity, the cardmembers may invite a limited number of guests to participate in the tournament subject to the Terms and Conditions herein.
2. The three (4) days three (3) nights golf experience includes (i) selected meals which is lunch at the golf courses and one (1) dinner, (ii) hotel accomodation for 3 nights stay inclusive of breakfast at The Athenee Hotel, a Luxury Collection Hotel, Bangkok (iii) goodie bag and (iv) return coach transfer to hotel and golf courses.
3. Payment must be made with a Maybank/ Maybank Islamic Credit Card (issued by Maybank & Maybank Islamic Malaysia, Singapore, Indonesia, Philippines, Brunei & Cambodia).
4. All fees paid for the the Maybank VISA Golf Program 2026 are strictly non-refundable. This includes, without limitation, deposits, prepayments, and full package fees, regardless of cancellation, rescheduling, or non-use of the package benefits. By purchasing the Golf Package, the Cardmember acknowledges and agrees that all payments are final

All transportation, additional nights on accommodation, administration costs and personal expenses, *(including but not limited to any other costs, fees and/or expenses that are incurred during the Event, participation in the tournament, and/or redemption and/or utilisation of any prize awarded)* for the tournament, shall be the sole responsibility of the Cardmembers.
6. Maybank is not the supplier of the good(s) or service(s) for the Event and makes no warranty or representation as to the quality and/or the fitness for purpose of the good(s) and the standard of service(s) provided by any third party or merchant for the Event. Any dispute over the good(s) or service(s) should be resolved directly between the Cardmembers and the relevant third party or merchant.
7. Maybank and its officers, servants, employees, representatives and/or agents (including without limitation, any third party service providers engaged by Maybank for the purposes of the Event) shall not be liable to the Cardmembers in the Event for any direct, indirect, special or consequential loss or damage (including but not limited to, loss of income, profits or goodwill) arising from or in connection with the Event unless caused by any gross negligence or omission by Maybank.
8. In the event of any inconsistency between these terms and conditions and any materials relating to the Event, these terms and conditions shall prevail.
9. These Terms and Conditions shall be governed by the Laws of Malaysia and subject to the exclusive jurisdiction of the Courts of Malaysia.
10. Maybank reserves the right to withdraw, cancel, suspend, extend or terminate the Event earlier in whole or in part and reserves the right to modify any of the terms and conditions contained herein, from time to time by giving at least minimum of twenty one (21) days ("day" shall have the same meaning as calendar day) prior notice thereof, the notice of which shall be in written letter or through

any other channel determined appropriate by Maybank. It shall be the responsibility of the Cardmembers to be informed of or otherwise seek out any such notice validly posted.

11. Maybank shall not be liable for any default of its obligation under the Event due to any force majeure events which include but not limited to acts of God, civil commotion, acts of war, strike, riot, lockout, industrial action, fire, flood, drought, storm, epidemic and pandemic or any events and circumstances of whatever nature beyond the reasonable control of Maybank.
12. By participating in this Event, the Cardmembers agree to be bound by the Terms and Conditions herein and agree and consent to allow his/her personal data being collected, processed and used by Maybank in accordance with the Maybank Privacy Statement, which may be viewed on www.maybank2u.com.my ("Maybank's Privacy Statement") and the PDPA Form for Individual Customers.

In addition and without prejudice to the terms in the Maybank's Privacy Statement and the PDPA Form for Individual Customers, the Cardmembers agree and consent to his/her personal data or information being collected, processed and used by Maybank for:

- a) the purposes of the Event; and
- b) marketing and promotional activities conducted by Maybank, including but not limited to any form of advertising or publicity media and materials such as audio and/or visual recordings published through newspapers, television networks, radio stations or online and digital media and on the Internet. Marketing and promotion activities include without limitation the use and/or publication of any details provided in and/or in connection to the entries, interviews material as well as responses and related photographs. In this regard, the Customers and the Guests agree to co-operate and participate in all advertising and publicity activities of Maybank in relation to the Event.

*Note: "PDPA" refers to Personal Data Protection Act (2010).

In the event Maybank requests from time to time that the Cardmembers provide the personal data and information, who might be individuals in the course of the Cardmember's transactions with Maybank, the Customers warrant that the Cardmembers have full legal authority and have complied with the Personal Data Protection Act 2010 by obtaining the relevant consent from the individual to furnish his or her personal data to Maybank (save and except for personal data collected from public domain or official documents) for Maybank to process such personal data under the terms and conditions governing this application and the Privacy Statement. the Cardmembers further undertake to inform and furnish the Privacy Statement to the individual before providing Maybank with the individual's personal data and shall, if requested, immediately provide evidence of the Cardmembers' compliance with the above to Maybank.

For the avoidance of doubt, any cancellation, revision, termination or suspension by Maybank of the Event shall not entitle any Cardmembers and/or any other person/entity to any claim or compensation against Maybank for any and all loss or damage suffered or incurred by such person or entity as a direct or indirect result of the act of cancellation, revision, termination or suspension.

15. Maybank's decision on all matters relating to the Event (including the interpretation of these Terms and Conditions) shall be final and binding on all customers and no further correspondence or attempt to dispute such decision would be entertained.
