

Maybank Cards Regional Visa Golf Program 2026

Terms and Conditions

1. This opportunity to participate in the Maybank Cards Regional Visa Golf Program 2026 ("Event") from 4 July 2026 to 7 July 2026 ("Event Date") is applicable to eligible cardmembers in Malaysia, Indonesia, Singapore, Cambodia, Philippines and/or Brunei ("Eligible Cardmembers"). Under this opportunity, the Eligible Cardmembers may invite a limited number of guests to participate in the Event subject to Maybank's prior assessment and the terms and conditions herein ("Terms and Conditions").
2. The Event consists of a four (4) days three (3) nights Golf Experience Package which includes:
 - (i) Three (3) nights hotel accommodation with daily breakfast at The Athenee Hotel, a Luxury Collection Hotel, Bangkok
 - (ii) Casual golf game at Siam Country Club inclusive of lunch and dinner
 - (iii) Golf tournament at Robinswood Golf Club inclusive of lunch
 - (iv) Return coach transfers between hotel and golf courses
 - (v) Goodie bag

The Golf Experience Package is not transferrable or exchangeable.

3. All payments for registration of the Event must be made with a Maybank or Maybank Islamic Credit Card (issued by Maybank or Maybank Islamic Malaysia, Singapore, Indonesia, Philippines, Brunei or Cambodia).
4. All fees paid for the Event are strictly non-refundable. This includes, without limitation, deposits, prepayments, and the full package price, irrespective of cancellation, rescheduling, and any package benefits that are either partially or fully unutilized. By purchasing the Golf Experience Package, the Eligible Cardmember acknowledges and agrees that all payments made are final and non-refundable under any circumstances.
5. All Eligible Cardmembers shall be solely responsible for all applicable taxes, rates, government fees and any other charges incurred in connection with their participation in the Event, including but not limited to costs and expenses relating to flight arrangement, airport transfers, travel insurance, pre- and post-Event hotel accommodation, hotel incidental charges (including mini bar consumption, room service, beverages, laundry and other items of personal nature), administrative costs, personal expenses and any other costs incurred before, during or after the Event, as well as in connection with the redemption and/or utilisation of any prize awarded.
6. Maybank is not the supplier of the good(s) or service(s) for the Event and makes no warranty or representation as to the quality and/or the fitness for purpose of the good(s) and the standard of service(s) provided by any third party or merchant for the Event. Should any issue or dispute arise in relation to the good(s) or service(s), the Eligible Cardmembers shall liaise directly with the relevant third party or merchant for resolution.
7. Eligible Cardmembers may be subject to terms and conditions imposed by Visa, where applicable.

8. In the event of any inconsistency between the Terms and Conditions herein and any materials relating to the Event, the Terms and Conditions herein shall prevail.
9. For the avoidance of doubt, any cancellation, revision, termination or suspension of the Event shall not entitle any Eligible Cardmembers and/or any other person/entity to any claim or compensation against Maybank for any and all loss or damage suffered or incurred by such person or entity as a direct or indirect result of the act of cancellation, revision, termination or suspension.
10. Maybank's decision on all matters relating to the Event (including the interpretation of these Terms and Conditions) shall be final and binding on all Eligible Cardmembers and no further correspondence or attempt to dispute such decision would be entertained.
11. Maybank shall not be responsible or held liable in respect of technical failures of any kind whatsoever, intervention, interruptions, and/or electronic or human errors in the administration and/or processing of the transaction performed via the MAE app, Maybank2u Biz, Maybank2u, or Maybank2e provided the same is not caused by Maybank.
12. Maybank reserves the right to withdraw, cancel, suspend, extend or terminate this Event and/or these Terms and Conditions earlier in whole or in part and reserves the right to modify any of the Terms and Conditions contained herein, from time to time by giving at least minimum of twenty one (21) days ("day" shall have the same meaning as calendar day) prior notice. Such notice shall be communicated through any channel or means deemed appropriate by Maybank, including but not limited to personal service, registered post, courier, electronic communication and/or publication on Maybank2u website at www.maybank2u.com.my.
13. By participating in this Event, Eligible Cardmembers agree to be bound by the Terms and Conditions herein and agree and consent to allow his/her personal data being collected, processed and used by Maybank in accordance with the Maybank Privacy Statement, which may be viewed on www.maybank2u.com.my ("Maybank's Privacy Statement") and the PDPA Form for Individual Customers.

In addition and without prejudice to the terms in the Maybank's Privacy Statement and the PDPA Form for Individual Customers, Eligible Cardmembers agree and consent to his/her personal data or information being collected, processed and used by Maybank for:

- a) the purposes of the Event; and
- b) marketing and promotional activities conducted by Maybank, including but not limited to any form of advertising or publicity media and materials such as audio and/or visual recordings published through newspapers, television networks, radio stations or online and digital media and on the Internet. Marketing and promotion activities include without limitation the use and/or publication of any details provided in and/or in connection to the entries, interviews material as well as responses and related photographs. In this regard, Eligible Cardmembers agree to co-operate and participate in all advertising and publicity activities of Maybank in relation to the Event.

*Note: "PDPA" refers to Personal Data Protection Act (2010).

14. In the event Maybank requests from time to time that the Eligible Cardmembers provide the personal data and information, who might be individuals in the course of the Eligible Cardmember's transactions with Maybank, the Eligible Cardmember warrant that the he/she has full legal authority and has complied with the PDPA by obtaining the relevant consent from the individual to furnish his/her personal data to Maybank (save and except for personal data collected from public domain or official documents) for Maybank to process such personal data under the terms and conditions governing this application and the Maybank Privacy Statement. The Eligible Cardmembers further undertake to inform and furnish the Maybank Privacy Statement to the individual before providing Maybank with the individual's personal data and shall, if requested, immediately provide evidence of the Eligible Cardmembers' compliance with the above to Maybank.
15. Maybank and its officers, servants, employees, representatives and/or agents (including without limitation, any third party service providers engaged by Maybank for the purposes of this Event) shall not be liable to Eligible Cardmembers in this Event for any direct, indirect, special or consequential loss or damage (including but not limited to, loss of income, profits or goodwill) arising from or in connection with this Event unless caused by any negligence or omission by Maybank.
16. Maybank shall not be liable for any default of its obligation under this Event due to any force majeure events which include but not limited to acts of God, civil commotion, acts of war, strike, riot, lockout, industrial action, fire, flood, drought, storm, epidemic and pandemic or any events and circumstances of whatever nature beyond the reasonable control of Maybank.
17. Maybank may disqualify/reject any Eligible Cardmembers who does not comply with the Terms and Conditions herein and/or are found or suspected to be tampering with the Event and/or its process or the operations of this Event which includes fraudulent activities involving any act of deceit and/or deception and/or cheating with regards to the Event.
18. These Terms and Conditions shall be governed by the Laws of Malaysia and subject to the exclusive jurisdiction of the Courts of Malaysia.
